We have reviewed and analyzed the Accounts Receivable Ledger Report for Dennis B. Brooks, M.D., Inc. as prepared by Valley Physicians Services, Inc. for the period January 1, 1996 through approximately August 15, 1997.

Based on our analysis and supporting documents (see Exhibit A), **we** have determined the following:

Accounts Receivable Ledger Summary

1. The medical-legal accounts included such services as initial exams cancelled, initial exam and report, deposition, review of records, conference, medical reports and phone conversations. 5. **Of** the Accounts Receivable Ledger Report provided, the pages were numbered 1 - 437. Certain pages were removed, which we have been informed did not include medical-legal charges. There were a total of 209 pages provided.

The range of case account numbers is 1240 to 1864 (625 total). There were 437 medical legal individuals assigned an account number. Thus, based on the information provided, 70% of the accounts represent medical legal services and 30% represent medical services.

Based on our analysis and supporting documents (see Exhibit B), we have determined the following:

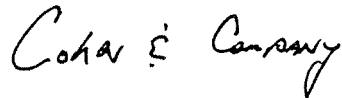
1. Dr. Brooks was hired for **483** assignments as reported on the listing provided.
